

## **EXECUTIVE SUMMARY**

This exceptional offering represents a rare opportunity to acquire one of British Columbia's most comprehensive placer mining operations in the heart of the legendary Cassiar Gold District. Located on the pristine shores of Dease Lake in Northwestern BC, this turnkey property combines extensive placer mineral rights with established residential and operational infrastructure, creating an unparalleled investment in Canada's gold-rich frontier.

The property features nearly 15,000 acres of placer claims across multiple gold-bearing creeks, complemented by a 22-acre waterfront base of operations complete with residential facilities, comprehensive workshop infrastructure, and an extensive equipment inventory. ## **LOCATION AND SETTING**

Dease Lake occupies a position of extraordinary significance in the story of Canadian gold mining. Located in Northwestern British Columbia along the Stewart-Cassiar Highway, this region served as the epicenter of the historic Cassiar Gold Rush and remains one of the province's most geologically rich areas for placer gold mining.

The creek was staked for 16 miles and in 1874 supported 700 miners, establishing this region as one of the earliest and most productive gold mining areas in the province.

The setting combines the rugged beauty of Northwestern BC with the practical advantages of established infrastructure. Dease Lake is a small but essential community with a population of around 400 residents, providing essential services while maintaining the authentic frontier character that defines this remarkable region. The property's location offers both the seclusion required for mining operations and reasonable access to supplies and services through the established community.

The dramatic landscape of the Stikine Plateau, with its pristine lakes, ancient mountains, and network of gold-bearing creeks, creates an environment where serious miners can pursue their passion while enjoying one of Canada's most spectacular wilderness settings.



# **INFRASTRUCTURE AND OPERATIONS**

The property serves as a comprehensive base of operations, featuring residential facilities, workshop infrastructure stocked extensively with tools and parts, and operational support buildings designed for both comfort and productivity.

#### **MAIN RESIDENCE**

The handcrafted log home, constructed in 1995, provides 1,176 square feet on the main level with additional finished space on upper and lower levels. The home features:

- 5 bedrooms spread over 3 levels
- 2 bathrooms; one on the main and one down with an additional third, unfinished bathroom upstairs
- Full kitchen and dining facilities
- Wood stove heating system
- Rustic charm with modern convenience

# SECONDARY CABIN/RESIDENCE ("THE JADE PALACE")

Built in 2012, this modern cabin provides additional accommodation with:

- 2 bedrooms
- 1 custom bathroom with jade and rock features
- Cement perimeter foundation
- Year-round water service
- Contemporary comfort in a wilderness setting
- Flexible use for guests, caretakers, or seasonal workers

#### HERITAGE CABIN

The property includes a remarkable piece of Canadian history: the original Laketon Hudson's Bay building dating back to the 1870s. This heritage structure connects the property directly to the fur trading era and the early days of the Cassiar Gold Rush, adding cultural significance to the operational assets.



#### ADDITIONAL INFRASTRUCTURE

#### 2 Mobile Homes on Skids:

Two mobile homes positioned on skids provide additional accommodation on the property. The skid-mounted design allows for potential relocation if needed.

#### PLACER CLAIMS AND GEOLOGICAL POTENTIAL

Recent operations have averaged 100 ounces per month during seasonal operations, with high-grade ground producing up to 1.3 ounces per hour of sluicing time.

The gold content averages 76% pure gold on Dease Creek, with higher concentrations on Berry, Rath, and Thibert Creeks reaching up to 88% gold content. This exceptional purity, combined with the variety of gold sizes from fine dust to substantial nuggets, creates multiple revenue opportunities for experienced operators.

#### **DEVELOPMENT POTENTIAL**

Conservative estimates suggest 75% of the claims on Dease Creek alone remain untouched by modern mining methods. High-potential areas including the McCrimmon bench, Nugget Gulch, and portions of the delta ground represent "lifetime and beyond" mining opportunities using current techniques and equipment.

# **JADE INVENTORY**

The property includes over 300,000 kilograms of mined jade. Recent market sales have achieved \$4.86 per kilogram after selling costs, with total inventory valued between \$1.5 and \$2 million.

# **ACCESS AND TRANSPORTATION**

#### **PRIMARY ACCESS**

Boat access across Dease Lake provides efficient transportation for personnel and supplies. The short crossing (under 1 kilometer) connects to the established community infrastructure and services. The property includes foreshore leases on both sides of the lake, securing water access rights and providing operational flexibility for current and future needs. Much of the fuel and machinery is brought in during the winter months via snowcat across the lake.

## **EQUIPMENT ACCESS**

A 13-kilometer rough bush road around the lake enables transportation of heavy equipment and large supplies when needed. Winter access via snowcat across the lake provides capabilities to transport fuel, machinery, and larger stock items.

# REGULATORY AND OPERATIONAL CONSIDERATIONS

#### PLACER CLAIMS STATUS

All placer claims are held under the British Columbia Mineral Tenure Act, providing secure tenure rights for exploration and development activities. Mineral and Placer Claims are applied for and acquired using the Mineral Titles Online (MTO) system.

#### PERMITTING REQUIREMENTS

Currently, mining permits are in the application process following the passing of the previous operator. The estate has restarted the permitting application process, which requires approximately 12 months for completion. Active water licenses remain in place.

## **OPERATIONAL COMPLIANCE**

All operations must comply with British Columbia's mining regulations, environmental standards, and Indigenous consultation requirements. The Mines Act regulates all mining activities in British Columbia, ensuring responsible development standards.

## HISTORICAL SIGNIFICANCE AND REGIONAL CONTEXT

The Cassiar Gold District holds an honored place in Canadian mining history, and this property sits at the heart of that legacy.



#### THE CASSIAR GOLD RUSH

The prospect of quick riches lured hundreds of placer miners to the Cassiar, where gold was discovered first at Dease Creek in 1872. Rich claims were later found at Thibert Creek and at McDame Creek. From McDame Creek in 1877 a 72-ounce solid gold nugget, the largest recorded to date in British Columbia. The largest gold nugget recovered in Dease Creek was in 1875 and weighed 50 ounces, demonstrating the exceptional quality of gold deposits in this district.

This property's claims cover ground that played a central role in this historic gold rush, connecting current operations to more than 150 years of continuous mining heritage.

#### **MODERN CONTEXT**

While the historical significance provides cultural depth, the region continues to demonstrate its geological importance. The Red Chris copper-gold mine is located approximately 80km south of Dease Lake illustrating the ongoing commercial significance of the area's mineral resources.

The continued viability of large-scale mining operations in the region provides confidence in the long-term value of established claims and infrastructure.
